What's required in a quality facilitator?

- Business and spiritual qualities as outlined on the Position Description attached.
- Willingness to attend a facilitator training session
- Willingness to arrange the 4-hour, once per month standing meeting agenda
- Willingness to listen in on a 1 hour quarterly all-facilitator conference call for moderator cross sharing.
- Most facilitators say this role takes very little extra time each month as they develop standard routines around food, venue, etc. Devotional preparation becomes part of their quiet times, etc.

Position Description: The qualities that Paul gave us for an overseer.

1 Timothy 3:2-7

Now the overseer must be above reproach, the husband of but one wife, temperate, self-controlled, respectable, hospitable, able to teach, not given to drunkenness, not violent but gentle, not quarrelsome, not a lover of money. He must manage his own family well and see that his children obey him with proper respect. (If anyone does not know how to manage his own family, how can he take care of God's church?) He must not be a recent convert, or he may become conceited and fall under the same judgment as the devil. He must also have a good reputation with outsiders, so that he will not fall into disgrace and into the devil's trap.

 - ❖ A solid business background with many years of business experience
 - ❖ A well-rounded understanding of how to integrate faith and work − comfortable with the Bible
 - ❖ A life experience as an effective business leader/mentor.

 - ❖ A sincere desire to help business leaders become the leader God has designed them to be (fulfilling their God-given role in our time)
 - ❖ A strong comfort with networking.
 - ❖ A comfort leading small groups and facilitating collaborative discussion
 - ❖ A heart for the unconvinced and excited about living out the Great Commission and enthusiastic in encouraging their members to do the same as well as discipling to produce ongoing spiritual reproducers.
 - ❖ Willing to be held accountable for own personal faith walk, family and life balance.
